Leon County's Annual 4th of July Celebration Funtier Days Centerville, TX

July 4th, 2022

Setup Time: All vendors should arrive with enough time to be entirely setup by 7:30am.

There are no assigned setup times. Please be aware the vendor area will be very crowded with other vendors and you may not be able to drive your vehicle to your booth space during setup time, which would require you to carry your booth contents from the parking area to your booth manually. Come earlier if you think this is going to be a problem. You are welcome to setup on Sunday the 3rd after 5:00pm. No security is provided.

No vendor vehicles will be allowed in the vendor area between 8:00am and 3:00pm

Thank you for your cooperation.

Festival Time: 9:00 a.m. until 3:00 p.m.

Move Out Time: After close of festival at 3:00pm.

Exception: Severe weather conditions, excluding normal temperatures.

Cancellation Policy: **Refunds are only granted if cancellation is received in writing at least 45 days prior to the Event or if the Event is cancelled by local government officials. No refunds due to weather. This is an outside event and is held rain or shine.**

Please try to return completed application and payment by June 15, 2022 (self-addressed stamped envelope enclosed)

Booth reservations are based upon the application and payment date received. First Come, first served.

- Outdoor booths are "open air", tables, chairs and canopies are NOT provided. NO anchors allowed in the pavement for canopies. NO shade is provided.
- Vendor must provide a heavy-duty extension cord, at least a 12 volt with ground, for booths with electricity. Cords MUST be secured to avoid being a hazard. MUST be at least 12 volts, 3 prong including ground.
- Each vendor MUST have an attendant at their booth at all times.
- The vendor will keep the occupied space in good order.
- Sales tax collection and payment will be the vendor's/exhibitor's responsibility.
- No child care will be available; each vendor will be responsible for their child or children.
- Handicap parking is NOT available in the vendor booth area.
- Signed and dated original of the Vendor Contract and Terms MUST be returned with the Booth Reservation Application and Fee.
- Submission of an application does not guarantee acceptance. The 4th of July officials reserve the right to select vendors.
- Vendor agrees to assume all risk of loss, injury, damage or theft of any kind or nature to any exhibit, merchandise, or component during the course of the event. Vendor also agrees to assume all liability for damage to property, person or persons arising from accidental or other causes incidental to movement and operation of the exhibit area and releases Leon County's Annual 4th of July Celebration Funtier Days & Leon County, Texas from any and all liability.
- Any violation(s) of the Vendor Contract and Terms MAY result in you NOT being invited to future Leon County's Annual 4th of July Celebration "Funtier Days". Your cooperation is appreciated.
- Trash cans and pick-up will be provided.
- Outside Toilets will be available and also limited indoor restroom access.
